Whiting Petroleum Corporation's Special Meeting of Stockholders will be held on November 8, 2017 at the Grand Hyatt Denver Grays Peak Conference Room, located on the 2nd Floor at 1750 Welton Street, Denver, Colorado 80202, at 8:00 a.m., Mountain Time.

The Proposal to be voted on at the meeting is listed below along with the Board of Directors' recommendations.

1. Adoption and approval of an amendment to the Restated Certificate of Incorporation to effect (a) a reverse stock split of the outstanding shares of Whiting's common stock and (b) a reduction in the number of authorized shares of Whiting's common stock, each as more fully described in the proxy statement.
