- (4) Includes 77.124 phantom stock units acquired through reinvestment of dividends on March 30, and June 29, 2007, at prices ranging from \$94.62 - \$115.77 per phantom unit.
- (5) The phantom stock units were accrued under the Johnson Controls Long-Term Performance Plan and are to be settled 100% in cash upon the reporting person's termination of employment.
- (6) Includes 69.069 phantom stock units acquired through the reinvestment of dividends on March 30, and June 29, 2007, at aprices ranging from \$94.62 - \$115.77 per phantom unit.
- Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were
- (7) accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock.
- (8) Includes 393.521 phantom stock units acquired through the reinvestment of dividends on March 30, and June 29, 2007, at pricec ranging from \$94.62 - \$115.77 per phantom stock unit.
