Of the total, 15,000 shares represent an award of a restricted stock grant. Fifty percent vests on 1/2/2008 and the remaining 50% on 1/2/2010.

- The number of underlying securities is based on the stock fund balance on November 17, 2006. The actual number of shares issuable
- (2) upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a November 17, 2006, stock fund price of \$84.99 per share.
  - (3) Vested stock released from plan.
- Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were
- (4) accrued under the Johnson Controls Restricted Stock Plan. The units are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock.
  - (5) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date, with the exception of retirement, when unvested options become 100% vested.
