(1) Grant of restricted stock pursuant to issuer's 2002 Restricted Stock Plan consisting of 11,787 shares of restricted stock over a four-year period, 50% after the first two years, 25% after the third year and 25% after the fourth year. The vesting will occur on the last calendar day of the appropriate year.

(2) These non-qualified options will vest in four equal installments beginning with 25% on December 31, 2005; 25% on December 31, 2006; 25% on December 31, 2007, and 25% on December 31, 2008.
