- (1) Represents a deferral of 1,565 shares of Hanesbrands Inc. common stock upon the vesting of restricted stock units (the "RSUs") granted to the Reporting Person on September 26, 2006 in accordance with the terms of the RSUs. The amount deferred was contributed to a Stock Equivalent Account balance under the Hanesbrands Inc. Non-Employee Director Deferred Compensation Plan (the "Plan").
- (2) Held by Mr. Coker's spouse, with respect to which Mr. Coker disclaims beneficial ownership.
- (3) Represents a Stock Equivalent Account balance under the Plan. Balances in the Stock Equivalent Account may not be reallocated and are settled on a share-for-share basis of Hanesbrands Inc. common stock.
- (4) 1-for-1

Balances in the Stock Equivalent Account are settled on a share-for-share basis of Hanesbrands Inc. common stock. Settlement generally occurs at the time specified by the Reporting Person at the time of the Reporting Person's deferral election, which in no case shall be prior to the January 1 following the first anniversary of the date the deferral election is made. With respect to the deferral of shares of Hanesbrands Inc. common stock resulting from the vesting of the RSUs, settlement will occur, in accordance with the terms of the RSUs, six months after the Reporting Person ceases serving as a member of the Board of Directors of Hanesbrands Inc.
