- Due to a clerical error by Issuer that originally occurred in connection with the acquisition by Reporting Person of shares of Issuer Common Stock through the exercise of rights in a pro rata rights offering by the Issuer in June 2005, Reporting Person has been incorrectly including 1,350 shares of Issuer Common Stock in the total amount of shares of Issuer Common Stock beneficially owned by (1) him on his Form 4 reports since that date. This error occurred when the Issuer erroneously attributed the exercise of rights to purchase 159,877 shares of Issuer Common Stock to Reporting Person instead of the 158,527 shares actually acquired upon exercise of rights, resulting in an over-reporting of share ownership of 1,350 shares. The total amount of shares of Issuer Common Stock owned by the Reporting Person has been corrected on this Form 4.
