As of February 24, 2012, the Target Fund reported a net asset value per share of \$11.9347 and the Acquiring Fund reported a net asset value per share of \$8.4561. The conversion ratio for the Target Fund's common shares was 1.41137167. In the Reorganization, Dr. Frank Fabozzi received 141 common shares of the Acquiring Fund in exchange for his 100 common shares of the Target Fund.
