 - (1) Grant of 15,400 restricted shares under the 2003 Plan as amended, restated and adopted, with a four year quarterly vesting schedule as to the lapse of restrictions thereof with 1/16 equal portions (962 shares) vesting quarterly, with the first 1/16 vesting on March 31, 2012 and thereafter equal 1/16 portions on June 30, September 30 and December 31 each year with the final 970 shares on December 31, 2015.
 - (2) Includes 15,400 restricted shares as detailed in Footnote 1. Also includes 15,000 shares of common stock granted as restricted stock. Restrictions lapse in equal quarterly installments of 1,250 shares with the final installment on December 31, 2014.
