The beneficiary does not have investment power over the shares of Class B Common Stock held by P.G. Nicholas Trust M. In addition, P.G. Nicholas Trust M may be deemed to be a member because P.G. Nicholas Trust M has agreed to certain voting agreements and limitations on transfers of shares of Class A Common and Class B Common Stock. P.G. Nicholas Trust M disclaims beneficial ownership of the securities reported herein except to the extent of its pecuniary interest therein.
