- (1) stock grant, these shares will vest on March 10, 2019 to the extent the performance goals are achieved. Of the grant of restricted stock, 50% is subject to vesting based on GEO's total shareholder return over a three-year period and 50% is subject to vesting based on certain return on capital employed performance goals being met.
- (2) This amount has been adjusted to reflect the reinvestment of cash dividends into shares of common stock.
- (3) The amount of shares has been adjusted to reflect a gift of 13 shares.
