- (1) Each restricted stock unit represents a contingent right to receive the cash value of one share of the Issuer's common stock. These restricted stock units pay out in cash in three installments: 2,476 units vested on 3/5/16, an additional 2,476 units vested on 3/5/17, and the remaining 2,475 units will vest on 3/5/18. The grant was previously reported.
- (2) The 2,476 shares were paid out in cash on the March 5, 2017 vest date at the closing price of the previous trading day (March 3, 2017) of \$110.46.
- (3) Aggregate of 46,420.14 shares listed in Column 5 of Table I includes: (a) 37,830 restricted shares previously reported and subject to adjustment; (b) 27.92 shares acquired through the Harris Corporation 401(k) Retirement Plan ("Plan") from 3/8/16 through 11/16/16; and (c) an additional 9.10 shares due to rounding of previous reports by the Plan's record keeper.
