The PAS Trust for the benefit of the Reporting Person distributed 35,600 to the Reporting Person just prior to the transactions reported herein. Since the transfer involved a mere change in the nature of beneficial ownership it was exempt from reporting under Section 16. Balance includes 3,815.272 shares held in a 401(k) plan for the benefit of Reporting Person.
