**MATERIAL FACT**

**Acquisition of Secondary Recovery Company**

Rio de Janeiro, December 09, 2011 – Petróleo Brasileiro S.A. – Petrobras informs to have purchased all the shares of the Secondary Recovery Company, publicly held share company, with headquarters located in the City of Macaé, State of Rio de Janeiro.

The Secondary Recovery Company was incorporated on June 01, 2001 with the special purpose of performing the supply of equipment to Petrobras for Pargo, Congro, Garoupa, Cherne and Carapeba fields located in Campos Basin, known as PCGC Project.

According to the provisions of the Investment Agreement, executed on December 13, 2001, Petrobras exercised the Call Option of 43,456,000 (forty three million, four hundred and fifty six thousand) common shares issued by the Company, representing 100% (one hundred percent) of its stock capital, all held by the Company's current shareholders.

As provided for in the Investment Agreement, the price for the call option was defined as BRL\$ 300.00 (three hundred reais), which corresponds to the payment of BRL\$ 100,00 (one hundred reais) to each of the current shareholders.
