## Explanation of Responses:

- (1) Includes 20,000 shares of restricted stock grants. 12,500 vest on 1/3/2008 and 7,500 vest on 1/3/2010.
- (2) Includes 2.15 shares acquired through the reinvestment of dividends on March 30, 2007, at a price of \$94.4436 per share.
- (3) The number of underlying securities is based on the stock fund balance on April 2, 2007. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a April 2, 2007, stock fund price of \$95.30 per share.
- (4) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (5) The phantom stock units were accrued under the Johnson Controls Equalization 401(k) Benefit Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service with the company.
- (6) Includes 1.39 phantom stock units acquired through the reinvestment of dividends on March 30, 2007, at a price of \$94.62 per phantom unit.
- (7) The phantom stock units were accrued under the Johnson Controls Annual Incentive Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service with the company.
- (8) Includes 13.809 phantom stock units acquired through the reinvestment of dividends on March 30, 2007, at a price of \$94.62 per phantom unit.
- (9) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
- (10) Includes 71.68 phantom stock units acquired through the reinvestment of dividends on March 30, 2007, at a price of \$94.62 per phantom unit.
- (11) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
