Millennium Management is also the general partner of the 100% shareholder of Integrated Assets, ICS Opportunities and Cognizant Holdings and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Assets, ICS Opportunities and Cognizant Holdings.
