(1) Since January 25, 2007, the date of Reporting Person's last filing, Reporting Person acquired 6 shares of WTM Common Shares under the Folsamerica 401(k) Plan. WTM Common Shares are purchased at fair market value on the date of purchase. The information in this report is based on a plan statement dated as of February 29, 2007. This amount also reflects a reclassification to Phantom Shares of 256 Common Shares previously reported as Non-Derivative Securities in the Reporting Person's last filing.

(2) Phantom Shares are convertible into Common Shares on a 1 for 1 basis.

(3) On March 28, 2007, the Reporting Person's deferred compensation account was credited with Phantom Shares equal in value to the ordinary dividend paid on the underlying WTM Common Shares on the dividend date.

The Phantom Shares are payable, as a result of the Reporting Person's previous separation of employment from WTM, in cash, in five equal installments that commenced in 2005. Final payment is due in 2009.

- (5) Dividends are automatically invested in Phantom Shares at the fair market price of the underlying WTM Common Shares on March 28, 2007, the date the dividends are deemed to be paid.
- (6) Reflects reclassification to Phantom Shares of 256 Common Shares previously reported as Non-Derivative Securities in the Reporting Person's last Form 4 filed on January 25, 2007.
