Senior Notes Indenture

On March 20, 2018, in connection with the previously announced private offering and sale of \$300.0 million aggregate principal amount of 5.625% senior notes due 2026 (the "Senior Notes") of Live Nation Entertainment, Inc. (the "Company"), the Company, the guarantors party thereto and The Bank of New York Mellon Trust Company, N.A., as trustee, executed an indenture (the "Senior Notes Indenture") relating to the Senior Notes.

Convertible Notes Indenture

On March 20, 2018, in connection with the previously announced private offering and sale of \$550.0 million aggregate principal amount of 2.5% convertible senior notes due 2023 (the "Convertible Notes" and together with the Senior Notes, the "Notes") of the Company, with such aggregate principal amount including \$50.0 million in aggregate principal amount issued pursuant to the exercise in full of the initial purchasers' over-allotment option, the Company and HSBC Bank USA, National Association, as trustee, executed an indenture (the "Convertible Notes Indenture" and together with the Senior Notes Indenture, the "Indentures") relating to the Convertible Notes.

Item 2.03. Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

The information set forth under Item 1.01 "Entry into a Material Definitive Agreement" is incorporated into this Item 2.03 by reference.

The Company completed offerings of the Senior Notes and Convertible Notes on March 20, 2018. The Convertible Notes were sold in private offerings in reliance on Rule 144A and the Senior Notes were sold in private offerings in reliance on Rule 144A and Regulation S under the Securities Act of 1933, as amended (the "Securities Act"). The offer and sale of the Notes have not been registered under the Securities Act, or any state securities laws, and unless so registered, the Notes may not be offered or sold except pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the Securities Act and applicable state securities laws.

Senior Notes Indenture

The Senior Notes will bear interest at the rate of 5.625% per annum, payable on March 15 and September 15 of each year beginning on September 15, 2018. The Senior Notes will mature on March 15, 2026. Prior to March 15, 2021, the Company may redeem up to 35% of the Senior Notes from the proceeds of certain equity offerings at 105.625% of the aggregate principal amount, plus accrued and unpaid interest thereon, if any, to the date of redemption. The Company may redeem some or all of the Senior Notes, at any time prior to March 15, 2021, at a price equal to 100% of the principal amount, plus any accrued and unpaid interest to the date of redemption, plus a "make-whole" premium described in the Senior Notes Indenture. In addition, on or after March 15, 2021, the Company may redeem some or all of the Senior Notes at any time at the redemption prices specified in the Senior Notes Indenture, plus any accrued and unpaid interest to the date of redemption. The Company is required to offer to purchase the Senior Notes at 101% of their aggregate principal amount, plus accrued interest to the repurchase date, if it experiences specific kinds of changes in control.

The Senior Notes are the Company's senior unsecured obligations and rank equal in right of payment with all of its existing and future senior indebtedness and senior to its future subordinated indebtedness. The Senior Notes are unconditionally guaranteed by certain of the Company's domestic subsidiaries. The guarantees are unsecured and rank senior to all of the existing and future subordinated indebtedness of such guarantors and rank equal in right of payment with all existing and future liabilities of such guarantors that are not so subordinated. The Senior Notes and the guarantees are effectively subordinated to the Company's existing and future secured indebtedness (including the secured indebtedness under the Company's senior secured credit facility) to the extent of the value of the assets securing that indebtedness, and will be structurally subordinated to all of the liabilities of any of our subsidiaries that do not guarantee the notes.

If an event of default as defined in the Senior Notes Indenture occurs and is continuing (other than specified events of bankruptcy or insolvency with respect to the Company), the trustee or the holders of at least 25% in principal amount of the outstanding Senior Notes may declare all the outstanding Senior Notes to be due and payable immediately. If an event of default relating to specified events of bankruptcy or insolvency with respect to the Company occurs, all the outstanding Senior Notes will immediately become due and payable without any declaration or other act on the part of the trustee or any holders of the Senior Notes.

The Senior Notes Indenture contains covenants substantially similar to the indentures governing the Company's 5.375% senior notes due 2022 and 4.875% Senior Notes due 2024 and limit, among other things, the Company's ability and the ability of the Company's restricted subsidiaries to:

- incur certain additional indebtedness and issue preferred stock;
- make certain distributions, investments and other restricted payments;
- sell certain assets;
- agree to any restrictions on the ability of restricted subsidiaries to make payments to the Company;
- create certain liens;
- merge, consolidate or sell substantially all of the Company's assets; or
- enter into certain transactions with affiliates.

These covenants are subject to important exceptions and qualifications and many of these covenants will not be applicable during any period of time when the Senior Notes have an investment grade rating.

Convertible Notes Indenture

The Convertible Notes will bear interest at a rate of 2.5% per annum, payable on March 15 and September 15 of each year, beginning on September 15, 2018. The Convertible Notes will mature on March 15, 2023 and may not be redeemed at the Company's election prior to the maturity date.

The Convertible Notes are convertible, at a holder's election, in multiples of \$1,000 principal amount, into cash, shares of the Company's common stock or a combination of cash and shares of the Company's common stock, with such form of consideration at the Company's election, based on the applicable conversion rate only under certain circumstances specified within the Convertible Notes Indenture. The initial conversion rate for the notes is 14.7005 shares of common stock per \$1,000 principal amount of notes (equivalent to an initial conversion price of approximately \$68.02 per share of common stock), subject to adjustment as provided in the Convertible Notes Indenture. Holders will not receive any cash payment or additional shares representing accrued and unpaid interest upon conversion of a note, except in limited circumstances. Instead, interest will be deemed paid by the

cash, shares of the Company's common stock or a combination of cash and shares of the Company's common stock paid or delivered as the case may be, to a holder upon conversion.

The Convertible Notes are the Company's senior unsecured obligations and rank junior in right of payment to the rights of our secured creditors to the extent of their security in the Company's assets; equal in right of payment to the rights of creditors under the Company's other existing and future unsecured unsubordinated indebtedness; senior in right of payment to the rights of creditors under indebtedness expressly subordinated to the Notes; and effectively subordinated to secured and unsecured creditors of the Company's subsidiaries. The Notes will not be guaranteed by any of the Company's subsidiaries.

If an event of default as defined in the Convertible Notes Indenture occurs and is continuing (other than specified events of bankruptcy or insolvency with respect to the Company), the trustee or the holders of at least 25% in principal amount of the outstanding Convertible Notes may declare all the outstanding Convertible Notes to be due and payable immediately. If an event of default relating to specified events of bankruptcy or insolvency with respect to the Company occurs, all the outstanding Convertible Notes will immediately become due and payable without any declaration or other act on the part of the trustee or any holders of the Convertible Notes.

With the exception of covenants restricting the Company's ability to merge, consolidate or sell substantially all of the Company's assets, the Convertible Notes Indenture does not provide for restrictive covenants.

Item 3.02. Unregistered Sales of Equity Securities

The information set forth under Items 1.01 and 2.03 is incorporated into this Item 3.02 by reference. The Convertible Notes were sold to the initial purchasers in reliance on Section 4(a)(2) under the Securities Act in transactions not involving any public offering, and the initial purchasers resold the Convertible Notes in reliance upon Rule 144A under the Securities Act to persons reasonably believed to be qualified institutional buyers. The Convertible Notes were sold to the initial purchasers for cash in an amount equal to 98% of their principal amount and were resold by the initial purchasers at an offering price of 100% of their principal amount. The initial maximum number of securities underlying the Convertible Notes, assuming the largest "make-whole" addition to the conversion rate under the Convertible Notes Indenture, is 12,127,885 shares of the Company's common stock.

Item 8.01. Other Events.

On March 15, 2018, the Company issued two press releases, one announcing that it had launched its private offerings of Senior Notes and Convertible Notes and one announcing that it had priced its private offerings of Senior Notes and Convertible Notes. Copies of these press releases are filed as Exhibits 99.1 and 99.2 to this Current Report on Form 8-K and incorporated herein by reference.
