In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) On December 22, 2016, the trustee of Settlement 1740 Trust #31 distributed to JNP 2010 Parachute Trust N2, 13,455 shares of Class B Common Stock. No consideration was paid in connection with the distribution from Settlement 1740 Trust #31. The distribution of shares of Class B Common Stock to JNP 2010 Parachute Trust N2 constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation.
