(c) On August 28, 2014, Superior Industries International, Inc. (“Superior”) appointed James F. Sisteck as its Senior Vice President, Business Operations, effective August 31, 2014.

Mr. Sisteck, 51, was Chief Executive Officer and founder of Infologic, Inc. from 2013 until August 2014. Prior to that, Mr. Sisteck was Vice President Shared Services & Chief Information Officer of Visteon Corporation (NYSE:VC) from 2009 through 2013 and its Vice President & Chief Information Officer from 2007 through 2009 and its Director Global Business Practices from 2003 through 2005. Before joining Visteon, Mr. Sisteck was Vice President Global Business Practices of Lear Corporation (NYSE:LEA) since 2003, Director of Program Management Electronics Division since 2000 and Director Advanced Engineering/Value Engineering/Quality since 1999. Mr. Sisteck has a MS in Engineering Management from the University of Michigan and a BS in Mechanical Engineering from Ohio State University.

Mr. Sisteck has extensive background in the automotive supplier industry. Mr. Sisteck will be responsible for information technology, supply chain management, and quality and business improvement.

There are no family relationships between Mr. Sisteck and any of the directors and executive officers of Superior, nor are there transactions in which Mr. Sisteck has an interest requiring disclosure under Item 404(a) of Regulation S-K.

Mr. Sisteck will receive an annual base salary of \$375,000. Mr. Sisteck may receive annual bonuses based on attainment of performance goals, determined by Superior’s independent compensation committee, in the amount of 50% of annual base salary.

Mr. Sisteck is receiving a grant of 6,500 shares of restricted stock under Superior’s Amended and Restated 2008 Equity Incentive Plan, which will vest on a *pro rata* basis in three annual installments.

Superior also is providing Mr. Sisteck a monthly automobile allowance. Mr. Sisteck is entitled to participate in all benefit plans generally made available to executive officers of Superior.
