  - (2) The reporting person also has an indirect beneficial ownership interest in 36,214.87 shares held in trust and 1,631.81 shares held in an ESOP.
  - (3) The option vests 25% on each of the first, second, third, and fourth anniversary of the grant date and has a term of ten years.
