On August 3, 2015, Home Properties, Inc. (the Company ) issued a press release announcing that the outside unitholders of Home Properties, L.P., the Company s operating partnership (the Operating Partnership ), have voted to approve the merger of the Operating Partnership with LSREF4 Lighthouse Operating Acquisitions, LLC, an affiliate of Lone Star Funds, and the related Agreement and Plan of Merger, dated as of June 22, 2015, by and among the Company, the Operating Partnership, LSREF4 Lighthouse Acquisitions, LLC, LSREF4 Lighthouse Corporate Acquisitions, LLC, LSREF4 Lighthouse Operating Acquisitions, LLC and UDR, Inc. (the Merger Agreement ).

A copy of the press release is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
