- (1) In connection with the vesting of 9,533 shares on November 3, 2017, a total of 3,723 of such shares were withheld by the Company in order to satisfy the reporting person's tax withholding obligations. The reporting person had no discretion with respect to such sale, which was conducted automatically in accordance with the issuer's corporate policies.
- Reflects the weighted average sale price. The range of prices for such transaction is \$3.30 to \$3.31.
