## SCHEDULE 13D

**Item 1. Security and Issuer**

The Schedule 13D filed with the Securities and Exchange Commission on February 11, 2013 (the Initial 13D ) by the Reporting Person with respect to the common stock, par value \$0.01 per share (the Common Stock ), of Winland Electronics, Inc., a Minnesota corporation (the Issuer ), is hereby amended to furnish the additional information set forth herein. All capitalized terms contained herein but not otherwise defined shall have the meanings ascribed to such terms in the Initial 13D.

**Item 3. Source and Amount of Funds or Other Consideration**

Item 3 of the Initial 13D is hereby amended and restated in its entirety as follows:

The Reporting Person may be deemed to be the beneficial owner of, in the aggregate, 231,581 shares of Common Stock. The aggregate purchase price of the shares of Common Stock purchased by the Reporting Person was approximately \$127,509.55 (including commissions). The source of funding for these shares of Common Stock was personal funds. 213,400 shares of Common Stock held by the Reporting Person were purchased in open market purchases. 18,181 shares of Common Stock held by the Reporting Person were issued pursuant to certain stock-based awards approved by the Issuer s Board of Directors on August 22, 2013.

**Item 5. Interest in Securities of the Issuer**

Item 5 of the Initial 13D is hereby amended and restated in its entirety as follows:

Based on the Issuer s Form 10-Q filed on November 8, 2013, there were 3,789,522 shares of Common Stock outstanding as of November 4, 2013.

- (a) The Reporting Person beneficially owns 231,581 shares of the Issuer s Common Stock, all of which shares are held in personal accounts, or 6.11% of the Issuer s Common Stock outstanding as of November 8, 2013. The Reporting Person has the sole power to vote, direct the vote, dispose and direct the disposition of such shares of the Issuer s Common Stock.
- (b) There is no shared power to vote or to direct the vote, or shared power to dispose or to direct the disposition of, any shares of Common Stock referenced in paragraph 5(a).
- (c) The following table sets forth all transactions with respect to the shares of Common Stock effected by the Reporting Person since the last filing on Schedule 13D. Except for 18,181 shares of Common Stock issued to the Reporting Person pursuant to certain stock-based awards approved by the Issuer s Board of Directors on August 22, 2013, all such transactions were purchases of shares of Common Stock effected in the open market, and the table includes commissions paid in per share prices.
