- (2) Shares of Class A Stock were disposed of by the Reporting Person pursuant to a 10b5-1 trading plan entered into on December 16, 2015.

- (3) The transaction was executed in multiple trades at prices ranging from \$36.1200 to \$37.1100. The price reported above reflects the weighted average sales price.
