ITEM 8.01 OTHER INFORMATION

On February 1, 2005, Harland Financial Solutions signed a definitive agreement to acquire Cincinnati, Ohio based, Intrieve Incorporated ("Intrieve"). Intrieve provides fully integrated technology solutions to financial institutions in an

outsourced environment. At February 1, 2005, WesBanco, Inc. ("WesBanco") owned 5,219 shares of Intrieve, which were obtained in the January 3, 2005 acquisition of Winton Financial Corporation ("Winton"). Intrieve provided core banking services to Winton. WesBanco expects to realize a total pretax gain on the conversion of these shares of approximately \$0.8 million, assuming Intrieve's shareholder approval. The gain is expected to be realized over the first, second and third quarters of 2005, with approximately \$0.7 million anticipated to be realized late in the first quarter of 2005 or early in the second quarter of 2005, with the remaining gain to be realized after 12 months.
