- (1) On December 14, 2010, the reporting person contributed 16,000 shares of NSC common stock to a grantor retained annuity trust for the benefit of himself and his three children. The remaining 14,980 shares were previously distributed to the reporting person and continue to be reported in this Form 4 as 'directly owned'.
