The Performance Rights vested on 2/13/2015, based upon the Compensation Committee's determination that the applicable performance criteria had been met as of 1/31/2015. 2,217 shares vested of which 84 shares were withheld for taxes. The reporting party elected to defer the balance of 2,133 shares to the Executive Deferred Compensation Plan.
