- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 1,093 units were acquired at prices ranging from \$6.88 to \$13.17. These transactions are exempt under rule 16a-11.
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 100 units were acquired at prices ranging from \$6.88 to \$11.62. These transactions are exempt under rule 16a-11.
- (3) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 154 units were acquired at prices ranging from \$6.88 to \$13.17. These transactions are exempt under rule 16a-11.
- (4) Options vest at a rate of 20% per year on each anniversary date, beginning on November 8, 2002.
- (5) Options vest at a rate of 20% per year on each anniversary date, beginning on November 7, 2003.
