Pursuant to Rule 13d-2 promulgated under the Act, this Schedule 13G/A (this “Amendment No. 1”) amends the Schedule 13G filed on September 14, 2012 (the “Original Schedule 13G”) (the Original Schedule 13G and this Amendment No. 1 are collectively referred to herein as the “Schedule 13G”). This Amendment No. 1 relates to the shares of common stock, par value \$0.10 per share, of Forest Oil Corporation, a Delaware corporation (the “Issuer”). Unless the context otherwise requires, references herein to the “Common Stock” are to such common stock of the Issuer. This Amendment No. 1 is being filed pursuant to Rule 13d-2(d) because a Reporting Person acquired beneficial ownership over 10% of the outstanding shares of Common Stock on January 29, 2013. Capitalized terms used but not defined herein shall have the meanings given them in the Original Schedule 13G.

Pursuant to an investment management agreement, CR Intrinsic Investors maintains investment and voting power with respect to the securities held by CR Intrinsic Investments. Mr. Cohen controls each of SAC Capital Advisors Inc. and CR Intrinsic Investors. CR Intrinsic Investments is a wholly owned subsidiary of SAC Capital Associates. By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) SAC Capital Advisors LP, SAC Capital Advisors Inc. and Mr. Cohen may be deemed to beneficially own 10,914,700 (a) Shares (constituting approximately 9.2% (a) of the Shares outstanding); and (ii) CR Intrinsic Investors and Mr. Cohen may be deemed to beneficially own 675,000 Shares (constituting approximately 0.6% of the Shares outstanding).
