Mosing may be deemed to share beneficial ownership of 119,024,000 shares (representing more than 10% of the outstanding shares) of Frank's International N.V.'s common stock, par value Euro 0.01 per share (the "Common Stock") held by FWW B.V. Mr. Mosing disclaims beneficial ownership of the Common Stock except to the extent of his pecuniary interest therein.
