(the Company) could not complete its filing on Form 10-Q for the period ended March 31, 2006 (the Form 10-Q) due to the fact that it has not completed the Form 10-K for the year ended December 31, 2005 (the Form 10-K) and the corresponding Forms 10-Q for 2005. As previously reported, the Company is former independent registered public accounting firm declined to stand for reappointment and the Company was unable to appoint a new independent registered public accounting firm until December 2005. The filing of the Form 10-K and the Forms 10-Q for 2005 is pending completion of the audit of the consolidated financial statements as of and for the year ended December 31, 2005. The delays regarding the Form 10-Q could not be eliminated by the Company without unreasonable effort and expense. The Company currently anticipates filing such Form 10-K, as well as the Forms 10-Q for the first three quarters of 2005, by August 31, 2006 and filing the Form 10-Q for the quarter ended March 31, 2006 within three weeks thereafter.
