The name of the issuer is Forest Oil Corporation (the "Company").

Weinstein (together, the "Reporting Persons") with respect to the ownership of the common stock by Saba Capital Master Fund, Ltd. ("SCMF"), Saba Capital Master Fund II, Ltd. ("SCMF II"), Saba Capital Leveraged Master Fund, Ltd., ("SCLMF") and Saba Capital Partners (Cayman), L.P. ("SCP").<sup>2</sup>

The Reporting Persons have entered into a Joint Filing Agreement, dated May 9, 2014, a copy of which is filed with this Schedule 13G as Exhibit 1, pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k)(1) under the Act.
