This Form 4 reports the grant of 8,750 shares of restricted stock under the Spartan Stores, Inc. 2001 Stock Incentive Plan ("Plan"). These shares will vest at the rate of 20% per year beginning on October 1, 2007, and will be fully vested on October 1, 2011. Prior to vesting, these shares will remain subject to restrictions in accordance with the Plan and the terms of the grant.
