The Units are redeemable for cash, based upon the fair market value of an equivalent number of shares of Common Stock at the time of such redemption, or, at the election of the Company, shares of Common Stock on a one-for-one basis.
- (2) 190,568 of the Units were exercisable on August 31, 1995 and the remaining 50,253 Units were exercisable on August 31, 2000.
