Item 8.01 Other Events.

On January 9, 2012, Peapack-Gladstone Financial Corporation (the “Corporation”) announced that it received approval from the U.S. Department of the Treasury (“Treasury”) for its request to redeem all of the remaining shares of the Corporation’s Fixed Rate Cumulative Perpetual Preferred Stock, Series A (the “Preferred Shares”), issued to Treasury pursuant to the Troubled Asset Relief Program Capital Purchase Program. On January 11, 2012, the Corporation expects to pay approximately \$14.5 million to Treasury to repurchase the Preferred Shares, including accrued and unpaid dividends for such shares. The Corporation’s redemption of the Preferred Shares is not subject to additional conditions or stipulations from Treasury.
