Performance shares, which are subject to vesting. Vesting requires both (a) continuing employment with the Corporation through the end of the Corporation's fiscal year 2013 (approximately June 30, 2013), and (b) achievement of at least the minimum cumulative performance result for the three-year period set forth in the Specific Terms and Conditions. Unvested performance shares are subject to repurchase by the Corporation at \$0.01 per share if eligible employment ends or, following the determination of actual Corporation performance versus metrics, to the extent such performance shares do not vest.

Restricted shares, which are subject to vesting. Vesting requires continuing employment with the Corporation as of the vesting dates.

(2) Restricted shares will vest as follows: 33.3% on January 25, 2011, 33.3% on January 25, 2012 and 33.3% on January 25, 2013. Unvested shares are subject to repurchase by the Corporation at \$0.01 per share if eligible employment ends before the vesting date.

(3) Stock options to purchase shares become exercisable if employment with the Corporation continues through the vesting dates. The options will vest as follows: 50% on January 25, 2011, 25% on January 25, 2012 and 25% on January 25, 2013.
