- On February 16, 2012 the reporting person was granted a total of 53,300 performance shares, providing for the grant of shares of restricted stock in 2013 based on the Company's total stockholder return in 2012 relative to the Company's peer group and National Association of Real Estate Investment Trust Retail peers. Based on these performance criteria for 2012, the reporting person was granted 35,924 shares of restricted stock and 17,376 performance shares were cancelled by the Company.
- (1) These shares vest 1/3 per year in 2014, 2015 and 2016.
 - (2) The shares issued are Restricted Stock. These shares vest 1/4 per year in 2014, 2015, 2016 and 2017.

- Each performance share award provides for the grant of restricted stock in the year following the performance year based on the Company's total stockholder return in the performance year relative to the Company's peer Group and the National Association of Real Estate Investment Trust Retail peers.
