On November 18, 2013, the Board of Directors of the Registrant approved an extension to its previously-announced stock repurchase plan which had expired on November 1, 2013. There are 59,837 shares of common stock which remain to be purchased under this repurchase plan. The Registrant had previously entered into a Rule 10b-5-1 plan in connection with the original stock repurchase program which will be extended for an additional 12 months. Repurchases will be made from time to time depending on market conditions and there can be no guarantee that all shares will be repurchased.
