CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 8,913,800 shares or 12.7% of the 71,297,500 shares of Common Stock believed to be outstanding.

Capital Guardian Trust Company, a bank as defined in Section 3(a)(6) of the Act is deemed to be the beneficial owner of 2,897,980 shares or 4.1% of the 71,297,500 shares of Common Stock believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.

Capital International Limited is deemed to be the beneficial owner of 4,513,920 shares or 6.5% of the 71,297,500 shares of Common Stock believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.

Shares reported by Capital Group International, Inc. include 147,050 shares resulting from the assumed conversion of 88,195,000 principal amount of 4.75% Convertible Note due 4/1/09.
