We will create community health hubs that will provide a new health care solution dedicated to improving consumer well-being and provide advocacy services to help answer questions about health, prescription drugs and health care benefits.

We are in exciting times and I know you have many questions. We expect the transaction to close in the second half of 2018, following regulatory and other required approvals. And until then, Aetna and CVS Health will continue to operate in every respect as two independent companies. Nothing is changing at this time. Even after the transaction closes, it will take time for the companies to completely integrate and for change to occur.

What each of us must do now is the same as it was before the announcement – we must run our businesses and meet our commitments and expectations for our customers, members and providers and help our members access the care they need. We will continue to make the provider experience simpler from the point of contracting all the way through paying claims. And when we do these things, our customers and providers will want to stay with us. And for those who aren't currently customers or providers with us today, they'll want to join us.

I am proud of what we have accomplished this year and I appreciate everything each of you has done -- and I appreciate everything you will continue to do for our customers, members and providers.
