Progress on share repurchase programme ING

ING announced today that, in line with the launch of its EUR 5.0 billion share buy back programme on 4 June 2007, the company has repurchased 1,767,988 (depository receipts for) shares during the week of 23 July until 30 July.

The (depository receipts for) shares were repurchased at an average price of EUR 31.74 for a total amount of EUR 56,120,148.79. For detailed information on the daily repurchased shares, see the ING website at www.ing.com/investorrelations.

The total number of (depository receipts for) shares repurchased under this programme to date is 31,854,009 ordinary shares for a total consideration of EUR 1,043,133,800.93. To date approximately 20.9% of the repurchase programme has been completed.

The repurchase programme is expected to run until June 2008.
