On October 20, 2010, PowerSecure International, Inc., a Delaware corporation (the Company), issued a press release announcing that it has received \$18 million of new awards for its Interactive Distributed Generation® smart grid power systems ( IDG systems ) and utility infrastructure projects. \$14 million of new business is for its IDG Systems, and \$4 million is for utility infrastructure projects.
