ANNOUNCE APPROVAL OF REORGANIZATION

CHICAGO (January 11, 2006) -- Van Kampen Asset Management announced today that the shareholders of Van Kampen Value Municipal Income Trust (NYSE/CHX: VKV) approved the reorganization of VKV into Van Kampen Advantage Municipal Income Trust II (AMEX/CHX: VKI) at a special meeting of shareholders held on January 11, 2006. The transaction is currently expected to close on or about January 27, 2006, subject to the satisfaction of certain conditions.
