**Item 1.01. Entry into a Material Definitive Agreement.**

*2006 Bonus.* The Board of Directors (the Board) of Wintrust Financial Corporation (the Company), based on the recommendation of the Compensation Committee, authorized the payment of annual bonus awards under the Company's 1997 Stock Incentive Plan and 2007 Stock Incentive Plan to the Company's executive officers for the year ended December 31, 2006. The Compensation Committee recommended awards based on its assessment of the Company's and each executive's performance measured against previously set financial and business objectives. The shares of restricted stock awarded vest on the first anniversary of the original award.
