On Nov. 18, 2008, the Special Situations Fund closed out a certain equity swap transaction with the counterparty thereto in the amount of 400,000 notional shares of Class A Common Stock of the Issuer at a price of \$7.040. The terms of the equity swap transaction did not

On Nov. 19, 2008, the Special Situations Fund closed out a certain equity swap transaction with the counterparty thereto in the amount of 143,365 notional shares of Class A Common Stock of the Issuer at a price of \$6.594. The terms of the equity swap transaction did not
