AWM also serves as the general partner of MGP Advisers Limited Partnership (MGP), the general partner of Special Situations Fund III QP, L.P. (SSFQP). Marx and Greenhouse are also members of MG Advisers L.L.C. (MG), the general partner of Special Situations Private Equity Fund, L.P. (SSPE). AWM serves as the investment adviser to SSFQP, and SSPE. (SSFQP, Cayman, and SSPE will hereafter be referred to as, the Funds). The principal business of the Funds is to invest in equity and equity-related securities and other securities of any kind or nature.
