(1) Restricted stock units convert into common stock on a one-for-one basis.

In connection with the vesting of restricted stock units, the Issuer withheld vested shares of common stock and agreed to satisfy the Reporting Person's tax withholding obligations in lieu of cash. The number of vested shares withheld was based on the closing price of the Issuer's common stock on February 8, 2019. Such shares were acquired as treasury stock by the Issuer.
