- (1) RSU time-based grant. Shares vest evenly over 3 years
- (2) 2/16/16 PSU Grant that cliff vests on 2/15/19 based on 2018 year-end performance results. Amount reported is actual number of shares that vested and were issued on 2/15/19.
- (3) 2/15/19 RSU Time-Based Grant. Shares vest evenly over 3 years
- (4) 2/15/18 RSU time-based grant. Shares vest evenly over 3 years.
- (5) 2/15/17 RSU Time-Based Grant. Shares vest evenly over 3 years
- (6) 2/16/16 RSU Time-Based Grant. Shares vest equally over 3 years.
