The Annual Meeting of Stockholders of Varian Medical Systems, Inc. (the “Company”) was held on February 12, 2015 (the “Stockholders’ Meeting”). The Company’s stockholders voted on the following three proposals at the Stockholders’ Meeting and cast their votes as follows:

Proposal One:

The following individuals were elected to serve as directors for three-year terms ending with the 2018 Annual Meeting of Stockholders by the votes set forth in the following table:

Directors Susan L. Bostrom, Regina E. Dugan, R. Andrew Eckert, Mark R. Laret, Erich R. Reinhardt, Venkatraman Thyagarajan and Dow R. Wilson continued in office following the Stockholders’ Meeting.

Proposal Two:

The stockholders approved, on an advisory (non-binding) basis, the compensation of the Company’s named executive officers, by the votes set forth in the following table:
