( Farmers ) issued a press release announcing that it has received all requisite regulatory approval for the proposed merger of National Bancshares Corporation ( NBOH ) with and into Farmers and the related merger of NBOH s wholly-owned subsidiary bank, First National Bank, with and into Farmers National Bank of Canfield, Farmer s wholly-owned subsidiary bank.
